MEMORANDUM OF UNDERSTANDING

BETWEEN

FEDERAL/PROVINCIAL/TERRITORIAL MINISTERS OF AGRICULTURE
CHARLOTTETOWN, PRINCE EDWARD ISLAND

JULY 6-7, 1993

Whereas:

The future of Canada's agri-food industry depends on improved trade performance in the global market place.

Federal, Provincial and Territorial Ministers agree to:

1. Pursue in partnership with industry the goal of reaching or surpassing \$20 billion in agri-food exports by the year 2000, with an increasing proportion of value-added products.
2. Improve collaboration, streamlining and coordination among departments and governments in support of both national and regional agri-food export trade development.
3. Evaluate existing and new programs related to the export of agri-food products against criteria such as:
 - sustainable incremental value-added and diversified export sales;
 - spinoff benefits for the agri-food sector;
 - efficient design and administration; and
 - reduction of duplication where appropriate.
4. Adopt a Canadian theme for international promotions which builds upon provincial, territorial and regional strengths and combine wherever possible federal, provincial and territorial participation in international promotions.
5. Coordinate access to technical assistance and/or programs available at federal, provincial and territorial levels with special emphasis on export readiness, market information and value-added product development.
