

Yukon RRSP Contributions 2010

Contributions to RRSPs, Canada and Yukon, 2010


In 2010, Canadians contributed \$33.9 billion to registered retirement savings plans (RRSPs), an increase of \$861.5 million, or 2.6%, from the 2009 total of \$33.0 billion. The number of Canadians contributing to RRSPs decreased by 0.2%, from 5,967,710 in 2009 to 5,956,010 in 2010.

Yukoners contributed \$37.8 million to RRSPs in 2010, up \$2.8 million, or 8.0%, from the 2009 total of \$35.0 million. The number of Yukoners contributing to RRSPs was also up, from 5,940 in 2009 to 6,200 in 2010, an increase of 260 people, or 4.4%. In 2010, 26.2% of Yukon taxfilers contributed to an RRSP, the second-highest rate in the country.

Nationally, the median RRSP contribution in 2010 was \$2,790, up \$110 from 2009. Yukon recorded the third-highest median RRSP contribution (\$3,310). Nunavut reported the highest median contribution at \$4,900 and the Northwest Territories the second-highest at \$3,610.

Characteristics of RRSP Contributors, 2010

- ♦ While women in Yukon represented 50% of the tax-filing population in 2010, they accounted for 53% of the number of RRSP contributors and 44% of total dollar contributions. Compared to the rest of the country, Yukon recorded the highest proportion of women contributors, and therefore, the lowest proportion of male contributors (47%). Yukon was the only province or territory where female contributors outnumbered males. The median RRSP contribution was higher for men than for women in all provinces and territories.
- ♦ In 2010, 21% of the total number of contributors in Yukon were under the age of 35, with their dollar contributions representing 11% of the total. Persons aged 35 to 44 accounted for 23% of contributors and 19% of contributions, while those aged 45 to 54 accounted for the largest percentage of total contributors, 30%, and 31% of contributions. Yukoners closest to retirement (aged 55 to 64) accounted for 23% of the total number of contributors and 32% of total dollar contributions.
- Nunavut had the lowest average age of contributors (42 years) in 2010. The average Canadian RRSP contributor was 45 years for the third consecutive year. Yukon contributors' average age in 2010 was 46, compared to 45 for the previous five years.
- ◆ Nationally, the median employment income for RRSP contributors increased \$1,400, or 2.7%, from \$51,570 in 2009 to \$52,970 in 2010. Yukon's median employment income for RRSP contributors was the third highest in the country at \$64,050, an increase of \$1,380, or 2.2%, from the 2009 figure of \$62,670.
