Balance of Trade 2008

Balance-of-trade figures are produced by Statistics Canada and reflect the balance of trade between Yukon and the rest of Canada, as well as total Yukon international trade. In this publication, Yukon's production and consumption of both goods and services is shown for each year from 2003 to 2008.

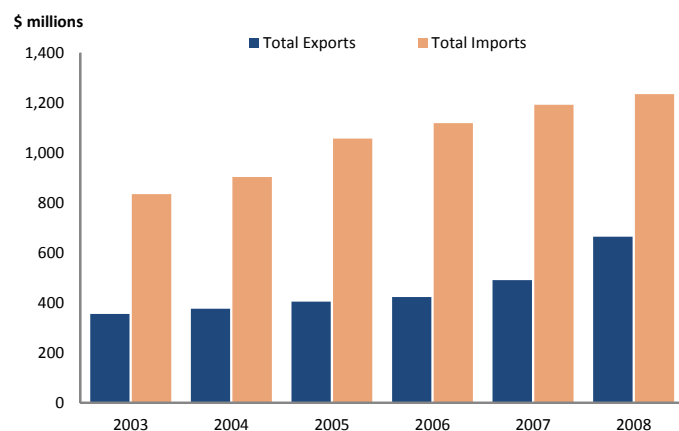

Between 2003 and 2008, the vast majority of Yukon-produced goods and services were consumed within Yukon. Since 2003, the value of goods and services exported has increased each year, from \$355.0 million in 2003, to \$664.7 million in 2008.

Between 2003 and 2007, the value of Yukon's exports remained between 14% and 16% of the value of all goods and services produced. This percentage climbed to 19.1% in 2008.

In 2003 and 2004, inter-provincial exports remained relatively steady at about \$190 million. Since 2004, inter-provincial exports have increased dramatically each year to over \$322.5 million in 2008.

Notably, international exports from Yukon took a large jump in 2008, increasing by 80% to \$342.2 million from 2007. The large increase in 2008 can be attributed to an increase in exports of minerals (e.g. Minto mine).

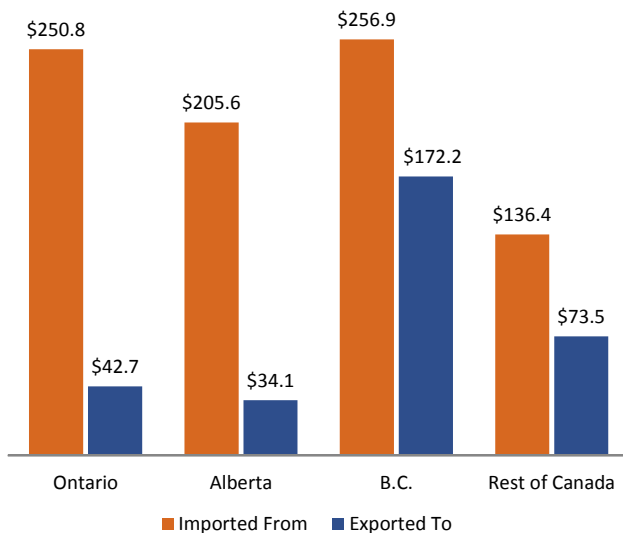

Balance of Trade between Yukon and Canada, 2008 (millions of current dollars)



Imports of goods and services as a percentage of total Yukon consumption of remained at fairly consistent levels between 2003 and 2008. In 2008, imports accounted for 30.5% of goods and services consumed.

Inter-provincial imports made up 68.8% of the total imports to Yukon in 2008, while international imports made up the remaining 31.2%.

Nationally, British Columbia is Yukon's biggest trading partner, with \$256.9 million worth of exports to Yukon and \$172.2 million worth of imports from Yukon.
